### New Democrat MLAs on the record: The cost of BC Liberal contracts with IPPs

“The Liberal government has locked us into contracts with private power producers that force us to buy very expensive power even when we don’t need it. Then we sell it back to the open market at a huge loss. “What Hydro does is it sends power to other markets when it’s advantageous to do so. [...] When the price is right. We’ve been doing that since the 1980s. We did it through the NDP period; the Liberals have been doing it, as well. What the Campbell government is trying to do is to stimulate the independent power sector. They’re trying to artificially create a marketplace for these high-priced, low-value producers of energy to get into the U.S. market. They’re saying that Hydro will become what they call an “aggregator” -- they will collect these inefficient, uneconomic projects and then try and flog them in the United States. [...] How do you do that without cross-subsidies from domestic ratepayers? I think that’s voodoo and magic. [...] Every energy economist that I’ve talked to -- Marvin Shaffer, John Calvert; I met with Jim Quail, who is a regular participant in Utilities Commission’s hearings. We’ve heard from first nations. Every single group that I’ve talked to about this energy plan has serious, serious concerns. The only group.... Well, there are two groups: The Independent Power Producers say, “Heck, yes. This is a great idea. We’re going to make a whole lot of money.” And the industrial users have stood down their opposition to independent power because there’s a clause in the Clean Energy bill that says they can negotiate their own deals -- fixed-price long-term contracts, not available to you and I, Vaughn, but available to large industry, traditional backers of the B.C. Liberals.” (Voice of BC, May 20 2010)

“People in this province are concerned that they are going to be paying more for electricity so that friends of the B.C. Liberals can strike it rich using our rivers. The B.C.
